# RIVERHEAD INDUSTRIAL DEVELOPMENT AGENCY OFFERS DISASTER RECOVERY ASSISTANCE

Riverhead Industrial Development Agency (IDA) officials have set up a program to provide financial assistance and help in navigating disaster relief offerings for small businesses recovering from super storm Sandy.

For businesses that need to undertake rebuilding, the IDA will work to provide an emergency sales tax letter allowing eligible businesses to be exempt from payment of New York State sales taxes on materials purchased for rebuilding. "We want to make as many resources available as we possibly can," said Tracy Stark-James executive director for Riverhead IDA, "We want to help small businesses rebuild and stay in Riverhead."

The IDA will also reduce its fees and, while following State law, look to streamline its normal procedure. This program is expected to offer economic benefits to reconstruction projects within Riverhead costing \$100,000 or more. We would also like to inform the public that representatives from the Small Business Administration, FEMA and the state's Small Business Development Centers have been helping business owners with aid forms at the Suffolk County Department of Labor site in Riverhead.

According to the Suffolk County Department of Labor Business Services Unit, whether you rent, own your own home, own your own business, or own a small agricultural cooperative located in a declared disaster area, and are the victim of this disaster, you may be eligible for financial assistance from the U.S. Small Business Administration (SBA).

Additionally, there will be **One on One Disaster Assistance for Businesses** made available through the Small Business Administration at Stony Brook Small Business Development Center (SBDC).
