### **Name of Public Authority:**

*Riverhead Industrial Development Agency*

### **Public Authority's Mission Statement:**

*Created and established in 1980 as a public benefit corporation, the Riverhead Industrial Development Agency's mission is to attract new businesses to Riverhead and to help existing businesses expand their operations and remain in Riverhead.*

*In doing so, the Riverhead Industrial Development Agency seeks to advance the job opportunities, health, general prosperity and economic welfare of the people of the Town of Riverhead and to improve their standard of living.*

*The Agency serves businesses by acting as a conduit for financial assistance and incentives through its authority to issue tax exempt or taxable Industrial Development Bonds and offer real property tax abatements, sales and compensating use tax exemptions, and mortgage recording tax exemptions. In addition, it assists business owners and developers in locating suitable sites for development; acts as a facilitator in meeting municipal and financial requirements; and serves as a grant administrator/applicant for critical resources leading to economic development and employment opportunities.*
